# The Business Context

Automotive manufacturers need to ensure robust integrations between ERP tools, accounting software, spend management platforms, and procurement systems.

The right accounts payable payment platform should have an intuitive user interface and deliver speed, efficiency, and accuracy in the receiving and processing of payments. It should also improve cash flow with versatile business payment options, automated workflows and strong analytics capabilities.

# **The Client**

With two production units in India, it has a total annual production capacity of 240,000 cars, and is one of the three innovation hubs for the global brand.

# The Business Challenge

The finance and treasury department of the client was challenged by the constraint of Goods and Service Tax (GST) being outside the purview of its systems. With GST payments having to be done through the government website, they could not have an implied approval matrix, and manual double-checking had to be done. Besides manual operations, it also had the disadvantage of dependency on a single avenue of net banking payment.

The client desired a digital and automated payment system that would simplify and ease GST payments, and add the versatility of multiple payment options, especially the use of its commercial credit card as a payment avenue.

# **The Solution**

Within a weeks implementation timeline, we deployed PayMate's industry-first - Accounts Payable solution for the client, with the following features:



#### Effective integration of ERP system to the GST network and banking partners

This enabled the client to automate their GST payment and settlement with high accuracy.

#### Fetching of all challans with multiple GSTIN codes in one step for bulk payment

On filing of GST returns on the GST portal, the client could generate challans towards outstanding GST payments due to the government.

#### Syncing of GST challans on the PayMate platform

Once synced, outstanding GST payments were displayed, and the client could select payments to be processed.

#### Make payments using their commercial credit card or via bank-to-bank transfer

Once processed, PayMate remits the required amount towards the outstanding GST payment to the GST portal through their commercial credit card or banking partners.

#### Higher security and compliance

Payment of GST through PayMate was more secure with automated multiple checks for a better audit trail.
